This show will be for **watercolor paintings only**. Opaque media such as gouache, acrylic, or casein will not be admitted to the show except with the limitations noted below.

The exhibition will include an invited group of Hawaiian glass artists. Glass art will not be juried.

Commission for sales is 30%.

Unframed painting sizes: minimum 7"x7", maximum 30"x40". All paintings must be framed.

<u>Dan Marshall – Juror</u>

Dan Marshall is a nationally renowned watercolor artist, demonstrator and instructor located in Denver, CO. He is an avid plein air painter, producing the majority of his work on location. He has been featured in and written articles for Watercolor Artist, Southwestern Art, Plein Air Magazine and OutdoorPainter.com and has received multiple awards from juried shows and invitational events. He has previously served as a juror for the National Watercolor Society, the Colorado Watercolor Society and the Laguna Plein Air Painters Association.

Dan has earned signature member status with the American Watercolor Society, the American Impressionist Society, Laguna Plein Air Painters Association and is a member of the Salmagundi Club.

Conditions and Rules

<u>Originality</u>: All entries must be original works of art, created in the last two years and not previously accepted into any juried HWS exhibition nor in any national/international exhibition by other societies. Artwork may not be a copy or likeness of another's work or a recognizable use of another's intellectual property. Artwork may not be a copy of photo reference material other than the entrant's. Artwork done under direct supervision during a class or workshop is not eligible for submission.

Media: Artwork minimum size 7x7", maximum 30x40" not including frame. Entries must primarily be watercolor on any appropriate, archival, 2- dimensional water media surface, natural or synthetic, including paper, paper- based board, or synthetic paper. Water soluble media such as gouache, casein, acrylics, water-soluble crayons, or inks comprising more than 1% of the surface area will not be allowed. Use of Chinese White, Titanium white, or similar opaque watercolors is also limited to 1% of the total surface. Oils, water-based oils, wax- based media, and computer-generated art are not allowed. Opaque material for highlights not exceeding 1% of the surface is acceptable. Collage is limited to 20% of the work surface and must be watercolor in its origin. All collage materials must be original design of the artist.

Submission Guidelines

Digital files must be .jpg or .jpeg format. Minimum of 1800 pixels on the longest side. File size a minimum of 500kb. Images must be cropped to the display image area only (no frame, no mat). Label your image file with your last name, hyphen, title, image size. (ie Jones- Plumeria-15wx20h.jpg). You may also list this information to the body of the email. **Attach** your image (do not drag and drop) to your email and send to robin@sagaradevelopment.com. Use subject line "Artist full name - Images for 2024 Members' Show"

Pricing: All art must be for sale. Artists shall indicate their pricing on their application to the show. HWS will earn a 30% commission on all sales, thus artists

must include the commission in their price.

Sales are conducted through HWS and <u>not</u> by individual artist's arrangement.

Entering and Paying

Enter online: https://www.hawaiiwatercolorsociety.org/2024-members-show
Online entry is recommended. You can complete registration forms and list your entries on the website when you checkout and pay your fee. We accept credit cards, debit cards and PayPal.

<u>Snail Mail:</u> If you prefer to submit your entry form and payment via mail, please print the entry form below. Mail your entry form and check and signed liability and authenticity agreement to the address and by the date shown on Page 1. Images must be cropped to the display area only (no frame, no mat).

E-mail your images to <u>robin@sagaradevelopment.com</u> with your image(s) attached to the e-mail (do not drag or drop but attach). See Submission Guidelines, above.

<u>Fees:</u> You may pay fees online (preferred) or by check/money order made payable to Hawai'i Watercolor Society. If you are mailing in your check, entry form and signed liability and authenticity agreement (address Page 1), it must be received by **the deadline shown on the first page.**

\$12.00 per show entry (ie. if entering 4 paintings, fee is \$48.00). \$12.00 single hanging fee if your work(s) are accepted.

Show Requirements For Works Accepted

<u>Framing:</u> Use professional materials for framing and consider the size and weight of your painting. Use D-rings and coated wire. Use glass, acrylic, or protective UV coating. Published price is inclusive of frame.

<u>Interisland and Mainland artists</u>: If your work is selected for the show, you must include **Prepaid Return Mailing Label** with your shipped painting(s). Cash or checks are <u>not</u> accepted, no exceptions. (See shipping address on page 1.) We highly

recommend shipping work using the **Air-Float System** which can be ordered online <u>airfloatsystems.com</u>. This is a secure packing system that makes packing and repacking artwork simple with the system proven strong enough to be used multiple times.

<u>Hanging Fee:</u> Hanging fee is \$12.00 per artist.

Work Must Hang throughout the Show: Work must remain in the gallery for the duration of the show. Sold work will be identified as such on the label but must remain in place through show closing.

<u>Sitting requirements:</u> Each artist will be responsible for covering three 3.5 hour shifts at DAC during the show. Due to the spaciousness of the gallery space, we must have 2 persons sitting each shift. Artists will get credit for one of their shifts by inviting one person <u>not exhibiting in the show</u> to sit the show with them. A sign up sheet will be available for scheduling purposes. If you are unable or unwilling to sit in the gallery for your shifts and need HWS to find someone to cover your shifts, you will need to pay HWS \$30. per shift for fulfilling your sit obligation as exhibiting artist.

Labels: Each painting must have a label securely affixed to the back of each piece with the following information: Title of Painting, artist phone number, artist email address, Price inclusive of frame.

Delivery: Framed work must be delivered in person to the DAC 2nd Floor Gallery at the time and date shown on the first page. The Downtown Art Center is located at 1041 Nu'uanu Ave., Honolulu, 2nd floor gallery. The entrance to the building parking lot is on Bethel Street, Chinatown Gateway Plaza. The elevator to the gallery is in the plaza and marked with a sign. (Note the gallery is separate from the DAC Gift Shop which is on the ground floor.)

Shipped art **must be received by the date shown on the first page.** Remember to include **prepaid return mailing label** in your shipped artwork package. Cash or checks are not accepted for return purposes. No exceptions. See mailing/shipping address on Page 1.
